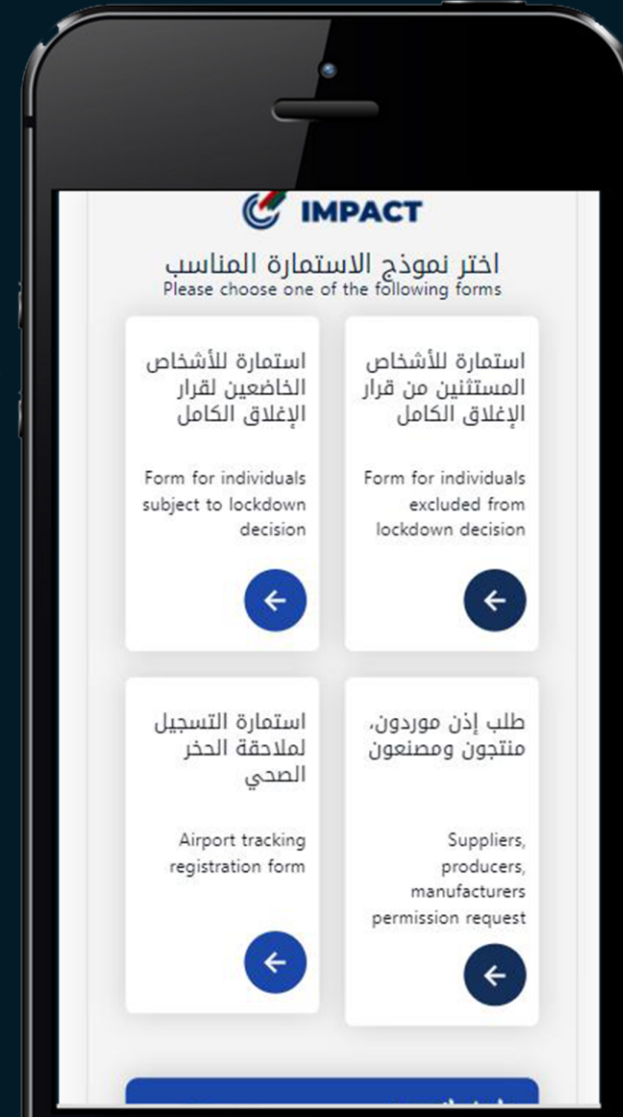
Download and activate the “Covid Leb Track”

Set your localization upon arrival and
respect the quarantine period (72 hours)
to avoid legal actions

Exemptions will be made to travelers with a proof of previous Covid19 infection holders of a positive IgG test, or holders of a document proving the reception of the Covid19 vaccine. Are also exempt from the quarantine obligation diplomats and their families, officials, official guests, officers, and UN forces

The Process



-Individuals **provides information on form** on covid.pcm.gov.lb

-Upon completion, individual **receives SMS** with username and password and link to download the app on selected phone number



Home or designated facility
quarantine in municipality

Individual is requested to
confirm quarantine location.



In case of quarantine
violation, IMPACT
tracks data point of
movement (not
trajectory).

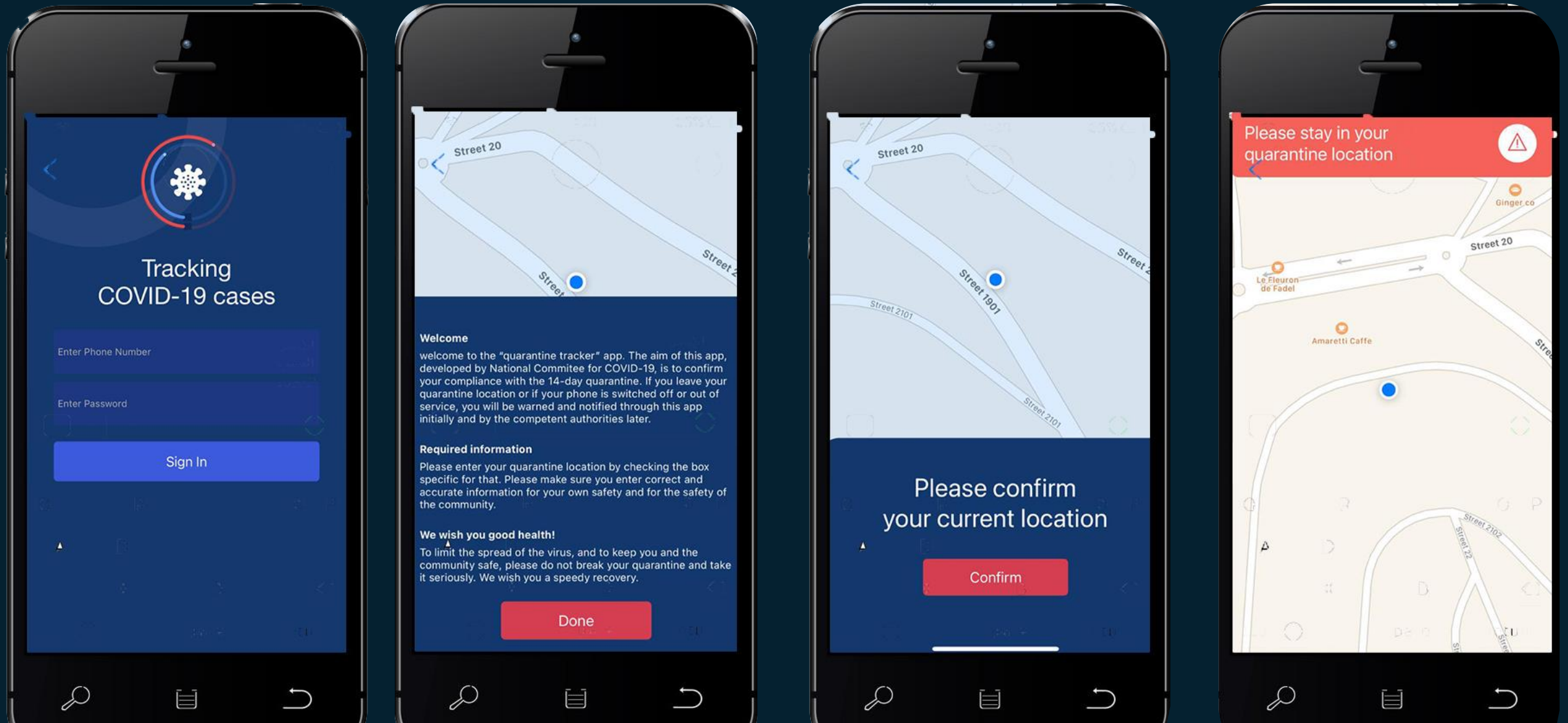


Notification is sent on the
phone requiring their
immediate return to their
location of quarantine



Municipality is notified on
IMPACT and will call
individual requiring their
return to quarantine location,
pending legal repercussions.

The role of the municipalities

The municipalities can follow up on:

- 1- People in quarantine
- 2- Quarantine places
- 3- Violation of quarantine



Exemptions

Exemptions will be made to travelers:

- 1- with a proof of previous Covid19 infection;
- 2- holders of a positive IgG test;
- 3- or holders of a document proving the reception of the Covid19 vaccine.
- 4- Are also exempt from the quarantine obligation diplomats and their families, officials, official guests, officers, and UN forces
